## **MA BELL'S DISFUNCTIONAL FAMILY**

So instead of integration, our friend "Mike", aided and abetted by his fellow co-conspirators on the board has come up with a different approach--let's break up Ma Bell unruly bunch into four somewhat related members of this dysfunctional mishpocha. The gang at ATT believes that they can blow so much smoke at the shareholders that they wont know what's going on--except when they look at their dividend checks and the stock price.

Over the years, the situation at ATT has been a classic case of misgovernance, and a good case can be made for malfeasance by its Board of Directors. They allowed Richard "Dick" Allen to perpetrate a decade of continuing screwups, including acquisition disasters; an inability to stem the competitive onslaughts of Sprint, MCI and others; to have a vision for the future of the telecommunications industry; and the creation of a competitive culture among ATT management.

The Board has embarked on a similar trip with Mike Armstrong. After all, what is more important to the Board members--their responsibilities to the shareholders or the very substantial perks they receive? Since the widows and orphans do not have much clout, is there a Federal agency willing to clean up the mess?
